Notes from this evenings NDP SG:

1) Distribution of flyer – schedule / date

Note: Comment from Paul regarding feedback to other Parishes - other parishes have been criticised for not giving their residents enough knowledge of the NDP's. This has come up during the inspection phase. There is a view that we have done all we can to keep people informed and although some may accuse the NDP SG of this we have plenty of evidence to disprove.

Note: Comment from Paul regarding A5 Flyer - other Parishes have commented that the A5 style flyers look very professional and help at the Consultation phase. Great idea in principle, however due to concerns around possible negative feedback of the NDP from some Parishioners, it is best to wait until after the 6 week Consultation period and then review for use at the referendum stage.
