## 1) Agree notes from last meeting.

The notes from the last meeting were agreed and accepted as accurate.

# 2) Final Responses & Feedback received from consultation.

Responses have been received from Herefordshire Council, a number of consultative bodies, the residents (35 residents responded) and one on behalf of a landowner via Zesta Developments.

# 3) Analysis of Results

LK has produced a table for each response with actions suggested. These have been circulated and reviewed in advance by the SG. LK has suggested actions from each comment.

#### a) Herefordshire Council

- As suggested by HC it was agreed that land used by Wye Valley Brewery and WSA should be
  designated as employment land. In addition, it was agreed this should extend to
  land occupied by NSA Events Bars. Action: SG to provide LK with map outline of NSA
  Event Bars property.
- Adopt additional policy as suggested about renewable energy.
- Identify community facilities on a map to be included in the document. Church, pub, village hall.
- LK asked that it be clarified with Sam Banks at Herefordshire Council if the changes to the plan are so significant that we need to consult a
- gain. ACTION BM to contact Sam Banks for clarification and for clarification on wording regarding the Lugg Valley phosphates issue.

#### b) Consultative Bodies

#### c) Residents

- Some comments unrelated to the NDP project to be redacted.
- Plant Hire business on Woodend Lane to be removed from the document where listed as a business.
- Settlement Boundaries. Some comments here relating to perceived inconsistencies around the
  definition of 'garden' as opposed to fields, paddocks and other woodland and amenity space.
  - Action: each concern needs to be reviewed, addressed and applied consistently.
- Hopton Lane Business Site. Comments regarding this need to be addressed. **ACTION: Review** the inclusion of this site and possibility of alternative as a residential property.
- Clarify with one resident which housing site allocation they are opposing. **Action: BM to ask the parish clerk to contact**.

## d) Landowners

- One response from Zesta Developments who submitted plans for Site 13 (subsequently refused by Herefordshire Council). These comments need to be considered.
- LK suggests replacement of the phrase 'affordable housing' for 'suitable housing'.
- ALL comments will be published but the names of residents will be anonymised.
